# **PUBLIC SESSION**

- 1. <u>Additions/deletions to Public Meeting Agenda</u>. Mr. Pagenhardt indicated that there were no additions or deletions to the Public Agenda for January 30, 2007.
- 2. Minutes of the Public Meeting of January 23, 2007 and Executive Session of January 23, 2007 were read and approved on a motion by Commissioner Holliday, which was seconded by Commissioner Glotfelty, and made unanimous by Chairman Gregg.
- 3. The Board of County Commissioners conducted the monthly department head staff meeting. In attendance were representatives from the following departments, agencies, and offices:

Margaret Jamison, Grants Resource Officer presented a recommendation that the Board of County Commissioners review and execute a Resolution that will facilitate a study funded by the State of Maryland Department of Business and Economic Development in the amount of \$100,000 to undertake a study to determine the feasibility of creating a Department of Parks and Recreation or an organization to manage and coordinate countywide recreation activities. (The County will provide \$30,000 in matching funds). The Board, on a motion by Commissioner Glotfelty, which was seconded by Chairman Gregg, and made unanimous by Commissioner Holliday, approved the execution of the Resolution by the Board and Mr. Pagenhardt.
- 5. The Purchasing Department presented a recommendation of bid award for Thayerville Prefabrication Steel Bridge (bid #07-0118). The Board, on a motion by Commissioner Holliday, which was seconded by Chairman Gregg, and made unanimous by Commissioner Glotfelty, approved an award to U.S. Bridge Division of Ohio Bridge Corporation for \$76, 720.00.
- 6. Carol Riley, Executive Assistant to the Board of County Commissioners and County Administrator, reviewed the meeting and committee schedule for the forthcoming week.
- 7. In compliance with the Maryland Open Meetings Act under section 10-509, a record of the Executive Session for January 23, 2007 is hereby documented on this date, the next open/public meeting of the Board of County Commissioners. The Board of County Commissioners, on a motion by Commissioner Holliday, which was seconded by Commissioner Glotfelty, and made unanimous by Chairman Gregg, moved into Executive Session under section 10-508 of the Maryland Open Meetings Law on this date to discuss personnel matters. The same motion adjourned the Executive Session. The Board executed a Statement of Executive Action/Approval that reappointed Mr. Pagenhardt to the position of County Administrator.
