**“Resolution of Fee Schedule for
the Office of Building Permits and Inspections”**

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF GARRETT COUNTY, MARYLAND, A BODY POLITIC AND CORPORATE, AND A POLITICAL SUBDIVISION OF THE STATE OF MARYLAND, ESTABLISHING A FEE SCHEDULE FOR BUILDING PERMIT FEES TO BE IMPLEMENTED AND ASSESSED BY THE OFFICE OF BUILDING PERMITS AND INSPECTIONS OF GARRETT COUNTY, MARYLAND.

EXPLANATION

WHEREAS, The Maryland Building Performance Standards Act of 1992, (the Act) Article 83B, Sections 6-401, et seq., of the Annotated Code of Maryland, requires that the Department of Housing and Community Development of the State of Maryland (the “Department”) adopt by regulation the International Building Code as the Maryland Building Performance Standard; and

WHEREAS, the Board of County Commissioners of Garrett County, Maryland, a body politic and corporate, and a political subdivision of the State of Maryland (the “County”) has adopted an Ordinance reflecting local amendments to the Act pursuant to and in accordance with the authority granted to the County, pursuant to the provisions of Section 6-402(d) of the Act (the “Code”). The County is authorized, pursuant to Section 103 of the Code to establish an Office of Building Permits and Inspections and is further authorized, by the provisions of Section 108 of the Code, to establish an appropriate fee schedule for building permits; and

WHEREAS, the County desires to establish a fee schedule for building permits in accordance with the provisions of the Act and in accordance with the provisions of the Code.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Garrett County, Maryland, a body politic and corporate, and a political subdivision of the State of Maryland, hereby resolves that the fee set forth below be charged by the Office of Building Permits and Inspections for building permits and such other activities as set forth in the fee schedule as may be necessary to conduct the business of the Office of Building Permits and Inspections, effective February 1st, 2005:

BUILDING PERMIT FEE SCHEDULE

With the exception of set fees for certain projects and services contained herein the following fee schedule is based upon a cost per square foot of all usable portions of a building or structure that are enclosed, including basements and cellars. The exterior rough dimensions will be used to calculate the enclosed areas.

| Additions | \$0.10 per sq. ft., \$100 minimum plus \$15 U&O |
