The Board of County Commissioners, on a motion by Chairman Crawford, which was seconded by Commissioner Gatto, and made unanimous by Commissioner Raley, appointed Bruce Swift to the Garrett County Planning Commission as alternate. The same motion re-appointed Troy Ellington and Jeffrey Messenger as members and moved Anthony Doerr from an alternate member to member. Official letters of appointment will be sent to each appointee under the signature of Chairman Crawford.
7. Mr. Nelson briefed the Board of County Commissioners on the protocol and format for the joint Planning Commission and Board of County Commissioners Public Hearing on March 8, 2011 to discuss amendments to the Garrett County Comprehensive Plan to recognize Ridgelines as Sensitive Areas in need of protection and recommend a framework for regulatory control of ridge top development.
8. The Board of County Commissioners reviewed a Department of Economic Development Project List initially presented to the Board on February 17, 2011. On that date Mr. Hinebaugh requested to designate potential/unbudgeted projects. The Board, on a motion by Chairman Crawford, which was seconded by Commissioner Raley, and made unanimous by Commissioner Gatto, approved a priority listing of potential projects to include projected funding sources. This project summary is attached to these Administrative Session minutes as Exhibit 1.
9. The Board of County Commissioners, on a motion by Commissioner Raley, which was seconded by Commissioner Gatto, and made unanimous by Chairman Crawford, moved into Executive Session under section 10-508 of the Maryland Open Meetings Law on this date to discuss personnel matters. The same motion ended the Executive Session and moved back into Administrative Session on this date.
10. Mr. Pagenhardt, Ms. Yoder, and Mr. Weeks reviewed the preliminary budget to include direction on tax rates, employee salary considerations, and other input prior to proceeding with a recommended comprehensive budget.
11. The Board of County Commissioners, on a motion by Chairman Crawford, which was seconded by Commissioner Gatto, and made unanimous by Commissioner Raley, approved a real property tax exemption for Adventure Sports Center International for Fiscal Year 2012.

12. Mr. Pagenhardt reviewed a number of other administrative legislation testimony matters with the Board of County Commissioners.
13. The Board of County Commissioners, on a motion by Commissioner Raley, which was seconded by Commissioner Gatto, and made unanimous by Chairman Crawford, moved into Executive Session under section 10-508 of the Maryland Open Meetings Law on this date to discuss personnel matters. The same motion ended the Executive Session.
