- 4. The Garrett County Department of Financial Services Purchasing Division presented the following Bid recommendation:

Bid #23-0209 – Visitor Center Deck and Handrail Replacement

This Bid consisted of five (5) Bid options. After reviewing the bids for compliance, the recommendation is to reject all bids for Options 1, 2, 4, and 5. Five (5) Bids were received for Option 3: Daystar Builder, Inc. (\$29,500), Mill Creek & Company (\$27,506), Beitzel Corporation (\$37,344), EARN Contractors, Inc. (\$45,700), and Colossal Contractors, Inc. (\$68,600).

After reviewing the Bids for compliance with administrative requirements and based on the feedback from the Department of Public Works - Facilities & Maintenance Division, the Garrett County Purchasing Division recommended awarding Bid# 23-0209 to Mill Creek & Company in the amount of \$27,506 for Option 3 Composite Lumber and Vinyl.

The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Savage, and made unanimous by Chairman Edwards, approved the Bid Award as recommended.

5. Garrett County Diversity & Inclusion Committee – Public Participation Survey launch. Garrett County Diversity & Inclusion Committee members Duane Yoder and Sarah Myers presented an update on the Committee and an overview of the Participation Survey being launched. This survey is a mechanism to collect stories and experiences of those living and working in Garrett County.
