## HazMat Team Update

Craig Umbel reported that the HazMat team presented information on the formation of their Level 2 Team to the Board of County Commissioners on August 6, 2018.

The team is hosting the 40 hr. HazMat Technician course. The 4-day training is scheduled as follows: **September 8**<sup>th</sup>-**9**<sup>th</sup> **and September 29**<sup>th</sup>-**30**<sup>th</sup>. Garrett College is hosting the training. The College is handling registration and providing class materials. We anticipate, at a minimum, 14 additional HazMat Tech's. Finally, Garrett County is planning an exercise for 2019/2020. The exercise request has been formally made to EPA by Emergency Management staff.

Terry Spear, Paul Harmon & Craig Umbel attended PA HazMat Conference at Seven Springs, PA. Finally, WV will be hosting a regional hazmat & interoperability exercise. They have invited all three Western Maryland counties to participate.

## **Department/Agency Updates**

**Alicia Streets-Social Services & Wayne Tiemersma-EMS** reported on a ongoing issue with repeat callers for medical assistance. Oftentimes these repeat callers do not need medical assistance (transport to hospital) but are in need of other resources. A small group will be assembled to discuss this issue and determine next steps.

William Swift-Public Schools announced that the recent active shooter training exercise held with MSP was successful and they anticipate this being an annual event. Also, NarCan is now available at all public schools-health room(s).

**Richard Wesolinski-Public Schools** reported that 125 bus drivers have completed the "Stop the Bleed" training. Participants had very positive feedback.

**Nathaniel Watkins-DoIT & William Swift-Public Schools** reported that they now have live public school camera feeds to Sheriff's Office. This was a low-cost and efficient alternative to the MD MVEIW System. They will also include EOC and MSP shortly.

**Dwayne Kitis-MIEMSS** reported that the issue of out-of-state (West Virginia) commercial medical transport providers should be resolved soon. New State Medical Director will be named following the retirement of long-time Director, Dr. Richard Alcorta.

**Shelley Menear, Garrett College** reported that they are still in need of generator/generator switch for the state designated shelter...Garrett College.

The College will be offering the 2-day ALICE instructor training program, at a cost of \$595 per student.
