3. Mr. Pagenhardt requested that the Board take under advisement personnel and organizational issues with the Department of Planning and Land Development. The Board of County Commissioners will continue to discuss matters related this this subject.

The Board of County Commissioners reviewed a request presented by Commissioner Raley during the October 1, 2013 Public Meeting for funding in the amount of \$25,000 that would be dedicated to his Friendsville Revitalization Proposal. Chairman Gatto and Commissioner Crawford agreed to add this issue to the agenda for the October 15, 2013 Public Meeting.

5. The Board of County Commissioners discussed the designation of Board Chairman for the fourth year of this term. No decision was made on this date.
6. At the request of Senator George Edwards the Board of County Commissioners reviewed draft legislation entitled – Garrett County – Industrial Wind Energy Conversion Systems – Setback Requirement. Certain provisions of this legislation that was enacted at the end of the 2013 Session of Maryland General Assembly were determined to be unconstitutional by the Attorney General therefore amended text of the legislation was required. The Board approved this codicil as drafted and Mr. Pagenhardt will forward this decision to Senator Edwards.
7. Mr. Pagenhardt reviewed a number of administrative and managerial issues under his jurisdiction and responsibility.
