- 1. Mr. Null indicated there was no addition or deletion to the Public Meeting Agenda. The Board of County Commissioners, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Public Meeting Agenda for May 6, 2019.
- 2. The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, approved the Public Meeting Minutes of April 16, 2019.

- 4. Proclamations:
 - ❖ Foster Care Month May 2019. The Board of County Commissioners presented the Garrett County Health Department staff with a proclamation in honor of this recognition.
 - Emergency Medical Services Week May 19-25, 2019. The Board of County Commissioners presented the Proclamation to representatives of the Emergency Medical Services in honor of this recognition.
- 5. The Garrett County Purchasing Department presented the following recommendation:

Bid #19-0418 - Puzzley Run Production Well Construction

Installation of two (2) production wells. Two (2) Bids were received for this Bid: Wayne's Water 'n' Wells, Inc. (\$126,464.50), and Sperry Drilling, Inc. (\$127,173.34).

After reviewing the Bids for compliance with administrative requirements and based on the feedback from the Department of Public Works – Utilities Division, the Garrett County Purchasing Department recommended awarding the Bid to Wayne's Water 'n' Wells, Inc., LLC for \$126,464.50.

The Board of County Commissioners, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Bid Award as recommended.

6. **Fiscal Year 2020 Garrett County Government Budget** - Scott Weeks, Director, Garrett County Department of Financial Services, presented a preliminary overview of the Garrett County Government Fiscal Year 2020 Budget:

Preliminary Overview:

- General Fund revenues show a net increase of \$306,971 from the prior Fiscal Year 2019 approved budget.
- Fiscal Year 2020 projected revenue is \$78,464,559 vs. Fiscal Year 2019 Revenue of \$80,307,588, the significant difference being \$2,150,000 of reserves used in Fiscal Year 2019 to balance the budget.
- Requested General Fund operating expenditures show an increase of \$2,764,094.
- Requested capital expenditures in FY 2020 total \$9,483,833, an increase of \$5,886,292.
- There is a total requested budget shortfall of \$10,493,415 even with budget cuts and deferred capital expenditures and capital projects there is still approximately \$3,500,000 shortfall in Fiscal Year 2020.

- Mr. Weeks stated that the County is at a point where it needs to consider drastically reducing services or raising revenues.
- Three potential revenue options to consider: Accommodations Tax, Income Tax and Real Estate Taxes.

The Board of Commissioners scheduled a Budget Work Session in order to further discuss the budget deficit and different options of raising revenues to include the pros and cons of each on Monday, May 13, 2019 at 5:30 P.M. in the Public Meeting Room.

 - The response has been very quick from both the State and local governments. The Rapid Response Team has resources available to provide help and support to those affected by the closing. The County will forward the suggestion for a community meeting to the Rapid Response Team.
