# PRAYER & PLEDGE OF ALLEGIANCE – Invocation by Commissioner Tichnell

#### **PUBLIC SESSION**

- Mr. Null indicated there was no addition or deletion to the Public Meeting Agenda. The Board of County Commissioners, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Public Meeting Agenda for February 1, 2021.
- 2. The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, approved the Public Meeting Minutes of January 19, 2021.
- 3. Update on County Response to COVID-19: Robert Stephens, Garrett County Health Officer provided an update on COVID-19 and vaccine.

### <u>Rate</u>

- Case rate is 18.17/100,000 lowest in state
- Positivity rate 6.89%, two weeks ago the County's rate was 14.9%. State average is 5.61% **Vaccine**
- 11.2% of the population has been vaccinated third highest in State.
- 107.9% of the vaccines we received has been administered "shots in arms". This number is over 100% because the "second shot" dose was used.
- The Garrett County Health Department (GCHD) Clinic has focused on Group 1A and 75 and older. GCHD will begin 65 and older this week, however clinics are fully booked.
- Vaccine supply is limited. The GCHD was receiving 600 doses a week. Currently allocated 300 per week by the State and vaccine has been allocated to Walmart in Oakland.
- Walmart is independent from the County and is not required to follow the same guidelines.
- Governor Larry Hogan announced that the National Guard will be deployed to help with vaccinations. Three sites will be opened next week in central Maryland. Western Maryland site has not been determined. At this time, we do not believe that vaccine doses will be transferred from Garrett County to the Western Maryland site.
- No vaccine has been spoiled. All doses have been used.

# **Questions**

- If you receive your first shot at Walmart where can they get the second shot? <u>Answer</u>: *Should make every attempt to get shot at Walmart.*
- Do the 300 doses allocated to Garrett County include the second dose? <u>Answer</u>: *No, GCHD will receive 300 doses plus what is required for the second dose.*
- Will the second shot be held in reserve? <u>Answer</u>: *No plans at this time*

On the recommendation from the Garrett County Agricultural Land Advisory Board and the Garrett County Planning Commission, the Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, approved each request. The Garrett County Department of Planning & Land Management will finalize each application and ensure the recording of the Garrett County Agricultural Land Preservation District Agreements for each individual.
