PUBLIC SESSION

- 1. Mr. Null indicated there was no addition or deletion to the Public Meeting Agenda. - 3. Update on County Response to COVID-19: Robert Stephens, Garrett County Health Officer provided an update on COVID-19 and vaccine.

<u>Rate</u>

- Case rate is 4.43/100,000
- Positivity rate 2.26%, lowest in the State. State average is 4.3%

Vaccine

- 15% of the population has been vaccinated.
- The Garrett County Health Department (GCHD) Clinic is now vaccinating people in Group 1C; however clinics are fully booked. No appointments are available until the first of March.
- Vaccine supply is limited. The GCHD receives 300 doses a week. This week's supply has been delayed from the federal stockpile. The GCHD borrowed enough doses from Garrett Regional Medical Center for this week's clinic.
- Walmart is independent from the County and is not required to follow the same guidelines. You must schedule an appointment through the Walmart website.
- New COVID strains are more infectious and deadly. However, the vaccine appears to be effective with the strains and provides protection. Everyone should remain diligent; wear masks, wash hands and get vaccinated.
- No vaccine has spoiled. All doses have been used.

4. Board Reappointments – Garrett County Local Emergency Planning Committee

Ratification of reappointment – two (2)year terms. Members are appointed by their respective agencies.
