Brian Bowers, Purchasing Agent, Garrett County Purchasing Department, presented the Board of County Commissioners with a list of surplus vehicles and equipment, with the majority to be sold as scrap to a recycler/salvage yard based on its condition.

PUBLIC SESSION

- Mr. Null indicated there was no addition or deletion to the Public Meeting Agenda. The Board of County Commissioners, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Public Meeting Agenda for April 20, 2021.
- 2. The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, approved the Public Meeting Minutes of April 5, 2021.
- 3. **Update on County Response to COVID-19:** Robert Stephens, Garrett County Health Officer provided an update on COVID-19 and vaccine.
 - Case rate is 14.8%, (4.8% the prior week) and Positivity Rate is 6.89%, which is higher than the State rate for the first time in six weeks. The increase is related to the UK variant, which is more contagious, but does not necessarily cause more serious symptoms.
 - Over 9,800 people have received the vaccine.
 - Without the help and support of volunteers the program would not have been as successful.
 - More opportunities for people to get a vaccination over the next three weeks:
 - Mass Vaccination beginning Tuesday, April 27, 2021. A mobile vaccination clinic will be open from Tuesday thru Saturday, 11:30 AM-7:00 PM at the GCC Technologies Building parking lot located in the Southern Garrett Industrial Park.
 - Working with EMS and FEMA for a GOVAC team to target communities by holding clinics in fire departments, churches, or similar community centers.
 - Within three weeks, anyone who wants a vaccination should be able to get one.
 - Johnson & Johnson Vaccine. Out of an abundance of caution, the vaccine has been paused due to adverse reactions in 6 out of 6 million doses administered. To put in perspective, 1 in 6 million had an adverse reaction while 1 in 750 people in Maryland died from COVID.
 - The Moderna vaccine will be used at the Mass Vaccination Clinic, at least for the first week. If
 Johnson & Johnson is approved, it could be used the second week. If you receive your first shot at
 the Clinic, they will return to administer the second dose; however, you can also receive the
 second shot at the Heath Department Clinics.

The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, adopted Resolution # 2021 - 1.

6. Garrett County Department of Public Works – Utilities Division – Water & Sewer Master Plan Amendments

The Board of County Commissioners conducted a Public Hearing on April 5, 2021, on proposed amendments to the Garrett County Water and Sewer Master Plan (Rosedale Services Area Creation and Service Area Boundary Change – Public Sewer Service). At that time, the Board determined to keep the public commentary record open for a two (2) week period to consider any public commentary. No comments were received.

The Board, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the amendments by Resolution 2021 – 2 and Resolution 2021 - 3.

7. ROAD NAME RESOLUTION - Resolution RN21-1

Garrett County Department of Planning & Land Management – Approval of names for two new roads in the Rocklick Creek Estates Development:

- Freedom Drive
- Freedom Ridge

The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, adopted Resolution RN 21-1.

8. The Garrett County Purchasing Department presented the following recommendation:

Bid #21-0408CS – Crushed Stone Aggregates

Five (5) Bids were received for this Bid: Maryland Minerals, George's Creek Stone, Keystone Lime, Allegany Aggregates, and Fairfax Concrete.

After reviewing the Bids for compliance with administrative requirements and based on the feedback from County departments, the Garrett County Purchasing Department recommended that based on the bid prices, location of the project, and hauling costs, each bid will be evaluated and purchased in the best interest of the County. Specifics of the award are on file with the Purchasing Department.

The total cost of Stone to be used in a project is the sum of the bid price and the hauling cost. The Garrett County Department of Public Works - Roads Division and Garrett County Department of Solid Waste & Recycling will determine which plant to purchase the asphalt based upon the location of the job.

Bid #21-0408 – Plumbing Services

Two (2) Bids were received: BYCO Enterprises, Inc. (\$70.00 Labor – 15% Material Markup) and Rush Services (\$78.00 Labor – 20% Material Markup).

After reviewing the Bids for compliance with administrative requirements and based on the feedback from the Department of Facilities & Maintenance, the Garrett County Purchasing Department recommended awarding the Bid to BYCO Enterprises, Inc. at \$70.00 Labor – 15% Material Markup.

The Board of County Commissioners, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Bid Awards as recommended.

About Salem:

- In 1979, The Maryland Salem Children's Trust was created, based on Christian principals, to provide a home, family, therapy, and educational services for children in need due to family instability (including children who have been abused or neglected), and/or emotional disability.
- Salem has made a positive impact on hundreds of youth over the 41 years of operation.
- At the outset of the Covid-19 pandemic, Salem had become unstainable due to a declining referral base, a severely limited per diem rate, and high operational costs in managing the program. These many factors contributed to its closure in June of 2020.
- Because of ever-increasing operational costs, advances in technology and infrastructure, while necessities to the residential and educational programs, were pushed to the "backburner." Much of Salem's technology is outdated, and even obsolete.
- Salem began partnership talks with Grafton in May of 2020.






About Grafton:

- Grafton has been a provider of therapeutic residential and educational services to youth with complex disabilities for more than 60 years.
- Based in Winchester, Virginia, Grafton employs more than 750 staff members between 5 locations and its services reach more than 3,000 clients each year.
- Grafton is licensed by the Virginia Department of Behavior Health and Developmental Services, and the Virginia Department of Education and accredited by Cognia and CARF.
- Grafton pioneered a trauma-informed approach to working with children with intellectual disability, developmental delay and/or autism that has led to a national consulting arm (Ukeru) at work currently with over 300 providers in 35 States.




An Integrated System of Care






Grafton's Philosophy of Care







What our Partnership will bring to Garrett County:

- Businesses created and strengthened This partnership will create a unified program that meets and supports the needs of a growing population of children with disabilities. Grafton's programming in Virginia is already viewed as a Center of Excellence in the area of residential and educational programming for this target population. It is Grafton's intention to continue to innovate that Center of Excellence model by leveraging the beautiful environs of Garrett County, Salem's equestrian programming (already in place), and the many leisure and vocational resources of our community.
- **Job created** It is anticipated that there will be an immediate need for recruitment and hiring of 25-30 qualified professionals. As the program continues to grow, it is anticipated that an additional 30-40 personnel will be hired within one year of opening.
- Students, workers, and leaders improved All personnel will be trained in Grafton's proven model of care and education, including Grafton's trademarked innovative techniques. These techniques are already being trained in over 250 organizations throughout the United States and Canada.
- Businesses and households with access to improved infrastructure Maryland Salem Children's Trust will need to expend significant resources in order to bring sufficient infrastructure to this project. All renovation and infrastructure supports will be locally sourced. The program will also provide a local resource for the community's youth with special needs.
- **Communities with enhanced capacity** This project will enhance this community significantly. Children's families will be encouraged to visit, bringing visitors to the county, and the program encourages the integration of the children into the community on a regular basis.
