PUBLIC SESSION

- Mr. Null indicated there was no addition or deletion to the Public Meeting Agenda. The Board of County Commissioners, on a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, approved the Public Meeting Agenda for May 3, 2021.
- 2. The Board of County Commissioners, on a motion by Commissioner Tichnell, which was seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, approved the Public Meeting Minutes of April 20, 2021.
- 3. **Update on County Response to COVID-19:** Robert Stephens, Garrett County Health Officer provided an update on COVID-19 and vaccine.
 - Case rate is 8.37%, slightly below State average.
 - 70% of county population over 65 is vaccinated.
 - 42.4% of county population over 16 is vaccinated compared to 55.9% state-wide.
 - Lower vaccination rate is not due to lack of vaccine but rather hesitant.
 - Variants of COVID are circulating and it important to be vaccinated. The vaccine is effective against the variants.

5. Real Property Exemption

Accident Community Housing Corporation – Request for Fiscal Year 2022 County Property Tax Abatement request under Annotated Code of Maryland, Section 7-502.

6. Garrett County Department of Solid Waste & Recycling – Amendment to the Ten Year Solid Waste Management Plan

In accordance with Maryland Department of the Environment regulations, the Board of County Commissioners conducted a *Public Hearing* on this date to receive public commentary on an amendment to the Ten Year Solid Waste Management Plan that would formally adopt methods for an Office Building Recycling Plan.

Kimberly Madigan, Recycling Coordinator, Garrett County Department of Solid Waste & Recycling, stated that this amendment is a requirement of the Maryland Department of the Environment. The amendment would require office buildings with 150,000 square feet of office space to provide containers necessary for the recycling of office paper, cardboard, metals, and #1 and #2 plastics. The receptacles are required to be in place by October 1, 2021. Currently, the County is unaware of any office building in Garrett County that would need to comply with this requirement.
