ADMINISTRATIVE SESSION

1. Appointment – Garrett County Agricultural Preservation Advisory Board – 3 Year Terms

The Board of County Commissioners, on a motion by Chairman Edwards, which was seconded by Commissioner Hinebaugh, and made unanimous by Commissioner Tichnell, appointed Staci Carr to the Garrett County Local Management Board. This appointment is fulfilling the unexpired term of Paul Petersheim and will end December 28, 2023. 6. **Resolution 2022 – 10: Adoption of Permit Fee Schedule** - Garrett County Planning & Community Development Division and the Office of the Garrett County Fire Marshal.

Chad Fike, Assistant Director, Garrett County Planning & Community Development Division, presented the proposed fee schedule increase. Building permit fees has not increased for over 20 years. This proposed increase is modest but still does not cover the cost of inspections.

The Board of County Commissioners, on a motion by Commissioner Tichnell, which is seconded by Commissioner Hinebaugh, and made unanimous by Chairman Edwards, approved Resolution 2022-10 Permit Fee Schedule (attached).

On a motion by Commissioner Hinebaugh, which was seconded by Commissioner Tichnell, and made unanimous by Chairman Edwards, the Public Meeting was closed and the Public Hearing opened at 4:15 p.m.

7. Siera Wigfield, Senior Planner, Garrett County Department of Planning & Community Development – Land Management Division, proposed a road name for a new road in the 1300 block of Hutton Road. Ms. Wigfield indicated a lack of consensus between residents on the proposed name of the road, so the Land Management Division chose the name Azalea Lane.

Residents who live on the road proposed Independence Lane stating there were no objections from other property owners. Another resident whose property fronts Hutton Road was concerned with his address being changed. It was determined that his address would remain as Hutton Road. This resident also stated that he was in favor of the name Independence Lane.

Ms. Wigfield stated that Independence Lane was a unique name in the 911 system and would be acceptable.

PERMIT FEE SCHEDULE

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF GARRETT COUNTY, MARYLAND, A BODY POLITIC AND CORPORATE, AND A POLITICAL SUBDIVISION OF THE STATE OF MARYLAND, ESTABLISHING A FEE SCHEDULE FOR BUILDING, FIRE PROTECTION, ELECTRICAL, AND PLUMBING PERMITS TO BE IMPLEMENTED AND ASSESSED BY THE DEPARTMENT OF PLANNING & LAND MANAGEMENT.

WHEREAS, The Board of County Commissioners of Garrett County, Maryland (the "County") is granted authority to adopt building, fire protection, electrical, and plumbing codes (the "Codes"); and

WHEREAS, The County, having adopted the Codes, is further authorized to establish reasonable fees in the issuance of permits required by the Codes; and

WHEREAS, The County desires to establish a fee schedule for building, fire protection, electrical, and plumbing permits,

NOW, THEREFORE, BE IT RESOLVED that the County Commissioners of Garrett County, Maryland do hereby adopt the following fees to be charged by the Department of Planning & Land Management in the issuance of Building, Fire Protection, Electrical, and Plumbing Permits.

BE IT FURTHER RESOLVED that the Garrett County Department of Planning & Land Management shall cause said resolution to be filed with the Clerk of the Circuit Court of Garrett County.
