Reports

Emergency Services John Frank

- Planning his retirement at the end of August of 2023.
- Emergency Services is currently hiring for a planner to replace a recent resignation.
- Fire Marshal Cieslarczyk also has recently resigned.
- Garrett County Emergency Management is still awaiting the release of federal earmarked funds for the backup 911 center radio project.
- The hazmat team recently had a major incident involving a fire at a local machine shop with a significant oil spill into a nearby stream. The incident was successfully mitigated with assistance from local fire and rescue and MDE.

Emergency Medical Services Wayne Tiemersma

Southern Garrett Rescue Squad Mark Clookie

- There are 5 new potential EMT's coming out of the next EMT class for Southern Rescue.
- A new ambulance has been ordered and an expected 2-year delivery time is anticipated.
- Southern Rescue will be celebrating its 50th anniversary in July.

Northern Garrett Rescue Squad Terry Spear

- A new MOU has been agreed upon and signed by Northern Rescue with Garrett County Government for EMS staffing.
- An open house was held in Friendsville the department was able to recruit 4 folks for the upcoming fall EMT class.
- There are several personnel in the current EMT class and doing well.
- Northern is still struggling with repairs of ambulances due to long wait times for parts.
- A new ambulance that had been purchased a few weeks ago will be delivered in the next 2 weeks.
- After a recent meeting with Garrett County Government and the Medical Director, changes are being implemented to allow for mutual aid ambulances to be alerted on the initial alert.

Bittinger Volunteer Fire Department, Justin Orendorf

- Bittinger will be celebrating its 50th anniversary as well this year.
- 3 new EMTs have recently completed class and are finishing up their mentorship program and are on the ambulance providing care.
- The department has 3 part time personnel that assist with covering EMS shifts as needed.
- There are 2 currently in the Garrett College paramedic program and potentially 2 more starting in the fall.
- Funding to assist with volunteers wanting to take the paramedic program would be very beneficial.

- The ESB workgroup tasked with ongoing operation review and recruitment met once since the last ESB. Squad town halls and still pending. A proposal from GCES for a Reserve Clinician Program was reviewed. The current volunteer squads have expressed concern about a county volunteer plan. GCES and the county administration plan to discuss options for recruitment next week.
- Fire/EMS Academy shareholder group (EMS, GCC, GCBOE, MFRI) continues planning for the fall of 2024. The group is awaiting further logistical information for the final plan.
- NGCRS and GCES continue to work collaboratively for ongoing operations. A new MOU has been agreed to in principle. GCES is still awaiting final signatures from NGCRS.
- SGCRS driving coverage has stabilized. We have had minimal request for driver coverage.
- 6 additional Interfacility transports have been completed since the last ESB. This has proven to be
 a long-term issue. Mon EMS has stepped up their assistance to Garrett Regional with the ongoing
 staff shortages that County Medical is experiencing. There still remains a significant gap. All
 stakeholders continue to work on long-term answers.
